GENERAL PROVISIONS:

1. The destination wedding couple fully understands and agrees that Elite Escapes Travel shall not be responsible or held liable in the event the destination wedding couple or guests are prohibited from attending destination wedding and honeymoon trip services due to illness, hospitalization, auto accident, transportation breakdown/disruption, traffic difficulties, acts of God such as hurricanes or inclement weather or other unforeseen incapacitation or other cause of non-arrival on the day of the destination wedding.
2. Elite Escapes Travel, and all vendors and travel suppliers shall NOT be held liable for any compensation or any damages (including punitive) due to non-performance of any destination wedding services resulting from such incapacitations, non-arrival, errors and/or omissions of any type.

1. This agreement or any attachments constitutes the entire agreement between the parties and may not be modified except in writing signed by both parties or by the acknowledgement of e-mail received by both parties. No other representations or promises have been made except those that are set out in this agreement. If any part of this agreement is adjudged invalid, illegal, or unenforceable, the remaining parts shall not be affected and remain in full force and effect.
4. If any suppliers/suppliers/service providers cancels prior to the date of the destination wedding, the destination wedding couple agrees that Elite Escapes Travel may substitute a new vendor with or without advance notice to the destination wedding couple at its discretion and any additional costs to be paid by the destination wedding couple. An alternative vendor will be agreed upon prior to the signing of this contract.

CHANGE & CANCELLATIONS:

In the event the destination wedding couple is forced to change the date of the wedding, every effort will be made by Elite Escapes Travel to transfer location reservations, sub-contractors, and travel suppliers to support the new date. The destination wedding couple agrees that in the event of a date change any expenses including but not limited to deposits and fees that are non-refundable and non-transferable are the sole responsibility of the destination wedding couple. There may also be additional charges above and beyond those set in the original contract.

Cancellation by the bride & groom:

Fees paid to Elite Escapes Travel are non-refundable. Deposits and fees paid to vendors are subject to their terms of refunds for cancellations.
